Civil Writ Petition under Article 226 of the Constitution of India for the issuance of a **Writ of Certiorari** for quashing order dated 25.11.2004 (annexure P-18) issued by Estate Officer, Haryana Urban Development Authority Hissar conveying the decision dated 11.10.2004 (annexure P-17) being the proceedings of the Screening Committee and for quashing the same, fro quashing the acquisition proceedings in respect of land measuring 18

marlas comprised of Khasra No.4669 in the revenue estate of Hissar upon which residential house of the petitioners allotted House No.8/19/2, Sector-13-P, Urban Estate Hisar has been constructed for quashing the show cause notice dated 14.12.2004 (Annexure P-20) issued by respondent No.3 regarding eviction of the petitioners from the land and the order dated 22.2.2005 (Annexure P-21) passed by respondent No.3 directing the ejectment of the petitioners from the land in dispute as the same are illegal and against the decision dated 2.9.1996 passed by a Division Bench of this Hon'ble Court and the policy letters framed by the respondents and for the issuance of a Writ of **Mandamus** directing the respondents to release the land of the petitioners from acquisition and to forebear from taking possession of the same or dispossessing the petitioners and their families or interfering in their possession and construction and for further directing the respondents to release residential house of the petitioners by way of allotment of residential plots for which they are entitled under the oustees policy and for the issuance of any other appropriate writ, order or direction.

Learned counsel for the petitioners submitted that earlier the State Government used

to allot plots to oustees even without advertisements. This is also his submission that out of the

acquired land, six plots have been carved out and petitioner's case may be considered in terms of

Annexure P-11 to this petition (as certain plots are left vacant). Annexure P-11, a letter from the

administrator, HUDA, to the Director, Urban Estates Haryana, refers to such plots, which are not

meant for allotment to the oustees, therefore, there is no ground for issuing a writ for allotment of

vacant plots to the petitioners. Moreover, it is made clear that any allotment of plot to any oustee

without due advertisement in any case would be viewed seriously as the existing process without

advertisement is likely to be misused.

With the aforesaid observations, the writ petition is dismissed.
