Policy regarding condonation of delay in depositing 15% Subject: amount and remaining amount/installments in case of E-Auction allotments.

- 1. At present, there is no policy to condone the delay in depositing 15% amount and the remaining amount/installments in case of allotment by e_auction. The matter has been under active consideration of the government for quite some time.
- 2. As per the present policy, any due amount which is not paid within the stipulated time (reckoned w.e.f. date of auction), results in cancellation of the plot and the amount earlier deposited stands forfeited.
- 3. To facilitate the allottees, it has been decided that an opportunity shell be given to such allottees to make the payment alongwith 10% surcharge on the delayed amount & 15% penal interest for the delayed period. This will be subject to the condition that the payment shall have to be made within 30 days after the stipulated period.
- 4. For brevity, the details will be as per Annexure 'A'.
- There will be no requirement for making application to condone delay by the allottee, it will be automatically available online.
