Subject:- Regarding providing space for opening of Liquor Vends.

Reference in continuation of this office memo no. A-7-UB-2021/2500 dated 16.07.2021 on the subject cited above.

It is intimated that a meeting under the Chairmanship of Sh. Devender Singh, IAS, Additional Chief Secretary to Gov. of Haryana Town & Country Planning Department was held on 25.04.2022.

After detailed deliberations in the meeting the following decisions were taken:-

1. The new excise year 2022-23, the Excise and Taxation Department shall intimate requirement of new sites in next 15 days to HSVP and HSVP also send details of sites which needs to be changed.
2. The liquor vend rent is to be charged from 01.01.2022 at new collector rate by HSVP.
3. The rent @6% up to 500sq. mtr.; Beyond 500 sq.mtr. @8% from the area in excess shall be charged of collector rate. Some parking area and approach shall be provided free of any charges.
4. The measurement of the area regarding liquor vend is to be measured by SDE(S) concerned and if the area found excess as given in the survey report the rent will be charged double.
5. Area of the liquor vends/ahatas is to be measured through satellite services by HSVP so that exact area and rental can be calculated. It shall also be fenced.
6. If HSVP could not recover rental from the vends, then the same be brought into the notice of Excise & Taxation Departments. The Department will ensure recovery of rent from these vendors for HSVP.
