Subject:- Clarification regarding transfer of Clinic sites and School sites allotted through e-auction.

Refer to the subject cited above.

It is intimated that earlier HSVP has been allotting clinic sites and school sites after inviting applications on the recommendations of the Zonal Committee headed by the Zonal Administrators after conducting interviews of the applicants and Clinic sites were transferable as per HSVP policy applicable.

As per the decision of the Cabinet taken in the meeting held on 27.03.1997 through HSVP policy dated 06.05.1997 it was provided that Nursing Homes, Clinic sites and Public schools would be allotted through auction.

Subsequently, issue arose as to on which terms transfer, condonation of delay, charging of extension fee etc. should be dealt in respect of clinic sites and School sites allotted through auction as per HSVP policy dated 06.05.1997.

Further HSVP has framed policy dated 07.08.2024 regarding transfer of institutional sites allotted through e-auction and this policy exclusively relates to institutional plots like plots located in Sector 32 & 44, Gurugram and Sector 20-A and 20-B, Faridabad.

Estate Officer, HSVP, Panchkula referred cases of School Site, MDC, Panchkula, Clinic Site No. 2, Sector-27, Panchkula and clinic sites No. 1 & 2, Sector-5MDC, Panchkula for clarification to the effect as to as per which policy transfer request shall be considered.

It has decided that a clarification may be issued that transfer of School sites/ Nursing Home/ Clinic sites sold through e-auction shall continue to be dealt as per the HSVP policy vide memo No. A-3-UB-2018/42377-78 dated 05.03.2019 **(Copy enclosed)** & memo No. A-1-99/18098-18119 dated 21.05.1999 **(Copy enclosed)** respectively and not as per HSVP policy dated 07.08.2024.
