**Subject: In Show Cause Notice No. 2317 of 2018 in Appeal Case No. 3006 of 2017 of the RTI Act, 2005 – Sh. Harinder Dhingra, Gurugram V/s Haryana Shahri Vikas Pradhikaran, Gurugram.**

This is in continuation of Commission's letter No. 6046/2019/3-IA dated 15.04.2019 on the subject cited above.

The Commission heard the matter on 22.05.2019 and passed following directions:-

"The representative of the respondent SPIO submitted that the replies of SPIOs-cum-Estate Officers, HSVP, Panchkula, Karnal, Kaithal, Rewari, Bahadurgarh, Sonapat and Faridabad is still awaited despite reminders dated 01.02.2018, 08.03.2018, 21.05.2018 and 22.05.2019.

Noting the submissions of the representative of the respondent SPIO, the Commission decides to issue show cause notices under Section 20(1) of the RTI Act, 2005 to the Deemed SPIOs-cum-Estate Officers, HSVP, Panchkula, Karnal, Kaithal, Rewari, Bahadurgarh, Sonapat and Faridabad for non-providing reply to the respondent SPIO which caused non-furnishing of information to the appellant. They are directed to submit their reply to the show cause notice by 09.07.2019 and be personally present during hearing on 16.07.2019 at 11.00 AM in the Commission's office.

The SPIO-cum-Coordinator (RTI), Deputy ESA, HSVP, Panchkula is also directed to present during hearing on 16.07.2019 at 11.00 AM in the Commission's office alongwith reply to the show cause notice".
